The Club will take all possible steps to ensure these images are used solely for the purposes they are intended. If you become aware that these images are being used inappropriately you should inform the Club Officer immediately. As parent/carer of the person named, I consent to the Club or a photographer appointed by Club photographing or videoing my child's involvement in pigeon racing for the period of time my child is a member, plus one year after they leave the sport for the purposes of publicising and promoting the club or sport.

PRIVACY STATEMENT - The National Flying Club take the protection of the data that we hold about you as a member seriously and will do everything possible to ensure that data is collected, stored, processed, maintained, cleansed and retained in accordance with current and future UK data protection legislation. Your information may also be given to third parties in relation to the reporting of stray pigeons. Your information will not be passed to third parties for marketing purposes.
